
## MILPITAS POLICE DEPARTMENT LAUNCHES POLICE TRANSPARENCY PORTAL

## MILPITAS UNVEILS FIRST PHASE OF COMPREHENSIVE ZONING ORDINANCE UPDATE

The City of Milpitas Planning Department initiated an update to the Zoning Ordinance in 2022 to ensure consistency with the City's new General Plan, as required by State law. Phase 1 of this multi-year effort entails zoning map changes as well as the creation of a handful of new zoning districts envisioned by the General Plan and the Metro Area Specific Plan. The new Business Park Research and Development (BPRD) Zone focuses on high-tech industries in the southwest, while Metro Area Zones promote high-density development near transit centers. Interested community members are invited to review the proposed zoning map changes and new zoning districts proposed in Phase 1 and provide comments. The Milpitas Police Department is kicking off National Public Safety Telecommunicator's Week with a huge thank you to the City's incredible dispatch team! In 2023, they handled a staggering 23,477 emergency 9-1-1 calls, answering 95.2% of those calls in under 10 seconds. Additionally, they handled 68,000 other calls for service! Thanks to their quick and efficient dispatching, the police department maintained an average response time of just 2 minutes and 51 seconds to emergency calls for service. Their ability to stay calm under pressure, gather crucial information, and coordinate resources effectively makes them the vital link in ensuring help arrives swiftly when it's needed the most. # DEVELOPMENT PROJECT CONSTRUCTION UPDATE

**308 Sango Court Apartments, 308 Sango Ct.**, a five-story over ground-level parking 85-unit affordable housing development by The Pacific Companies.

Corridor work is progressing well with all electrical, mechanical and plumbing trades and structural strapping. The second level is almost ready for gypsum drywall at the corridors. Steel studs on the first floor are close to completion. Exterior walls are continuing with waterproofing installation. See the below photo.



**Pulte Group Townhomes**, 1355 California Circle, a 206-unit development that includes 35 traditional townhomes, 96 stacked townhomes/condos, and 75 low and moderate-income rental apartment units by Pulte Group.

Underground utilities removal almost completed with some utilities and services still needing to be capped. Soil stockpiles are covered to prevent degradation from wind and rain. See below photo.



**Milpitas Square located at 190 Barber Ct., existing shopping mall with diverse retail & Asian dining**

**Lumen Townhomes, 2001 Tarob Ct.**, two buildings with a total of 32-unit townhome-style condominiums residential development by KB Homes.

Exterior drywall is being completed and all rough electrical, mechanical, and plumbing trades are in progress. See photos below.



**Parkside at Tarob Ct (Phase III) Townhomes, 551 Lundy Pl.**, an 89-townhome residential development by Toll Brothers, Inc.

Installations of roof framing and interior stairs are moving forward for the last building. See photo below.



**Parkside West Townhomes, 675 Trade Zone Blvd.**, three-story 13 townhome-style condominium complex consisting of a total 90 units which includes 78 condominium units with 12 ADUs residential development by Toll Brothers.
