## THE CITY OF MILPITAS HONORS OFFICER JOSH WELLS AS 2025 VETERAN OF THE YEAR

Milpitas proudly honored its U.S. military veterans and active-duty personnel from every branch during a formal Veterans Day ceremony held Tuesday, November 11 at Veterans Plaza. The Veterans Commission recognized Officer Josh Wells as the 2025 Veteran of the Year. A Milpitas native and former U.S. Army Ranger with the 1st Battalion, 75th Ranger Regiment, Officer Wells completed three deployments to Afghanistan and Iraq, later continuing his service in the Army Reserves as a Combat Medic. After returning home, he joined the Milpitas Police Department and is a proud member of the Honor Guard. Known for his integrity, commitment, and strong ties to the community, Officer Wells exemplifies the spirit of service that this award celebrates.



## CITY OF MILPITAS AND MIDCON REACH TENTATIVE AGREEMENT

The City of Milpitas and the MidCon (*Mid-Management and Confidential*) employees bargaining unit have reached a tentative one-year agreement, successfully averting a potential strike and ensuring the continued delivery of essential public services. Key provisions of the agreement include a 5% general salary increase for all members, longevity pay recognizing years of service, and a one-time, non-pensionable lump-sum payment. The agreement reflects a shared commitment to fair compensation, fiscal responsibility, and collaborative labor relations, honoring the contributions of MidCon employees while maintaining essential services for the community. The City Council is scheduled to consider adoption of the agreement at its December 2, 2025 meeting.

## HALL MEMORIAL PARK COURTS REOPEN AFTER MAJOR RENOVATION

After a brief closure for renovations, the Hall Memorial Park Pickleball and Tennis Courts have officially reopened, unveiling a series of upgrades aimed at enhancing play for residents of all ages. The refreshed facility now features two dedicated tennis courts and six dedicated pickleball courts, each resurfaced with a sleek, modern color palette. Visitors will also find a new spectator viewing area, improved signage, and a streamlined queueing system designed to make joining a pickleball match easier than ever. In response to community feedback, the City has also installed acoustic sound-dampening panels to help reduce noise for nearby neighbors. The improvements reflect Milpitas' growing demand for high-quality outdoor recreation spaces.

With renovations complete, the courts are once again open to the public. Local players are encouraged to bring their paddles and rackets and enjoy the upgraded facilities.

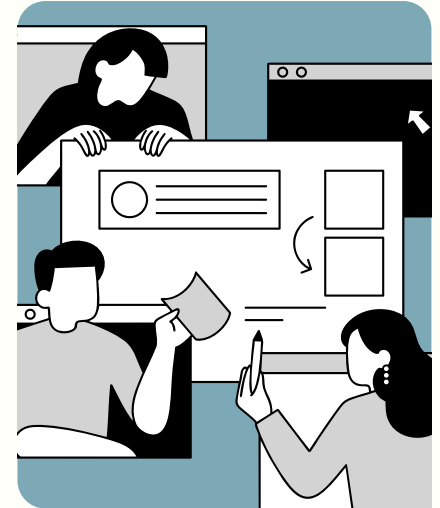

The exterior plaster and the interior through drywall have been completed at Building 1, a five-plex with 2-ADU units. At Building 2, a five-plex the installation of interior finishes is currently underway and the interior rough all trades have been completed. Exterior framing has been completed and interior work on rough all trades is in progress at Building 3, a six-plex. Construction of third floor and roof framing is underway at Building 4, an eight-plex with 2-ADU units. At Building 5, an eight-plex with 2-ADU units' construction of third floor framing is underway. Construction of second floor framing is underway at Building 6, an eight-plex with 2-ADU units. Construction of foundation formwork and reinforcement detailing is underway at Building 7, an eight-plex with 2-ADU units. At Building 20, a four-plex, interior work in preparation for the final is currently underway.

# DEVELOPMENT PROJECT CONSTRUCTION UPDATE

**Pinnacle Townhomes**, 1752 Houret Ct., eight three-story buildings consist of 56-unit townhome-style condominiums with 24 ADUs residential development by City Ventures

At Building 2, a nine-plex with three ADUs the driveway aprons have been poured and final inspections will start next week. At Building 3, a five -plex the roof has been completed with siding and stucco in progress. Building 4, a six-plex with six ADUs is the first out of eight building to pass the final inspections and can now be occupied. At Building 6, a six-plex with six ADUs the mechanical, electrical and plumbing inspections are done and the drywall is almost complete. The roof is complete with siding and stucco in progress. The framing for Building 7, a 12-plex has been completed up to level 4. The slab on grade has been complete for Building 8, a five -plex.

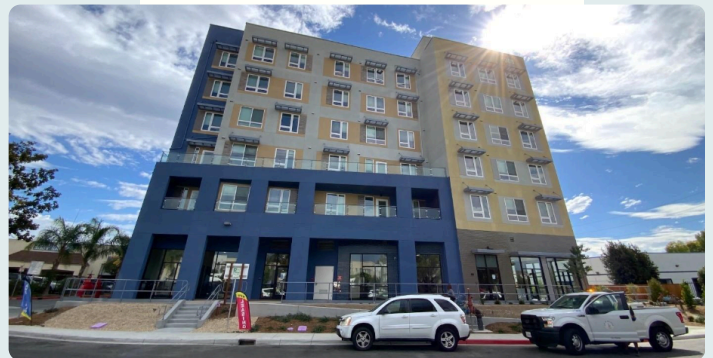

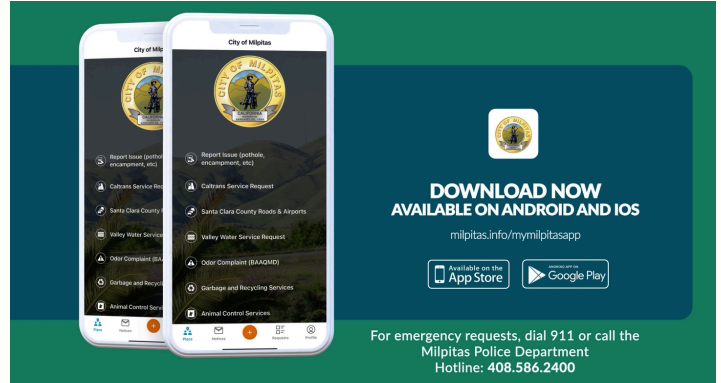

## SOLID WASTE SPOTLIGHT

Do you have stuff you need to get rid of? Did you know there are several FREE convenient waste disposal services available to Milpitas residents?

### Self-Haul Voucher Program

Request up to two self-haul vouchers per year to dispose of bulky items at the Zanker Material Processing Facility. Each voucher allows the disposal of one vehicle load (up to 3 cubic yards) of approved items. Call Milpitas Sanitation at 408-988-4500 for more details about what is accepted, and to request a voucher.

### Household Hazardous Waste (HHW) Drop-off

Safely dispose of Household Hazardous Waste (HHW) such as old paint, pesticides, and cleaners by scheduling a drop-off appointment at a Santa Clara County hazardous waste collection facility. To make an appointment, visit [HHW.org](http://HHW.org) or call 408-299-7300. Proper disposal of HHW helps protect the environment and keeps harmful materials out of the waste stream.

## BULKY ITEM BLITZ!

Are you a single-family dwelling with bulky items you need to get rid of? Milpitas Sanitation's FREE Bulky Item/On Call Clean-Up Program can help!

**Interested? Here's what you need to do:**

1. Contact Milpitas Sanitation to make an appointment.
2. Place up to 3 bulky items OR 2 white bags (provided by Milpitas Sanitation) OR up to 14 household 32-gallon garbage bags at your curb before 6:00 AM on your scheduled collection day.
3. Make sure the items don't block the street or access to garbage/recycling carts.

Single-family dwellings have 4 free pick-ups per rolling year, and the scheduled appointments should be made no less than 8 weeks (2 months) apart.
