
CITY OF MILPITAS INVITES QUALIFIED MURALISTS

The City of Milpitas invites qualified muralists to submit qualifications to be considered for various mural projects as part of the City's new Mural program. The program is expected to produce four murals per year, with at least one being painted by a Milpitas resident. The Milpitas City Council is keen on using murals to amplify the City's beautification efforts. Murals could range in size from very small projects on utility boxes to very large projects coordinated with other public agencies. They could be on City-owned property or in partnership with private property owners. Members of the public are invited to nominate mural sites for consideration. Proposed sites are evaluated by the Arts Commission and recommended for City Council approval. The Milpitas Arts Commission will review qualifications this Fall with the goal of developing an extensive portfolio of prequalified muralists. The Arts Commission has also expressed interest in prequalifying muralists of diverse cultural backgrounds, artistic styles and experience levels, to provide potential artists for projects of all sizes and budget levels. Santa Clara County and the City of Milpitas have partnered to provide COVID-19 testing by appointment at two sites:


Milpitas Community Center (457 E. Calaveras Blvd.)



MILPITAS SMALL BUSINESS ASSISTANCE PROGRAM LAUNCH

The City of Milpitas has launched the 2022 Milpitas Small Business Assistance Grant Program to support local businesses that have been negatively impacted by the COVID-19 pandemic. The \$1,500,000 grant program is funded by the American Rescue Plan Act (ARPA) and approved by the Milpitas City Council to assist Milpitas small businesses with resiliency and recovery efforts. The grant program will provide \$5,000 grants and free technical assistance to over 280 Milpitas small businesses. The grant application period is open from January 31 through March 1, 2022. HOW MILPITAS SAVED NEARLY 4 MILLION GALLONS OF WATER

The City of Milpitas owns and operates a Neutral Output Discharge Elimination System (NO-DES) truck to clean and maintain the City's drinking water pipelines. Prior to utilizing a NO-DES system, Public Works staff would clean drinking water lines by opening fire hydrants to flush water through the mains at a high velocity. This method would scour the interior walls of the water mains to remove any naturally occurring deposits of minerals or sediment that settle out of the water over time, with the water hitting city streets bound for storm drains.

With a NO-DES system, instead of water hitting city streets and getting flushed down storm drains, it is caught, filtered and sent back into the system, effectively removing sediments and improving water quality. Disinfectants can also be added to further improve water quality and ensure its safety, something previous methods could not achieve. The NO-DES process results in improved water quality and water savings which benefits the City's water rate payers. In 2021, staff estimates that the system saved residents roughly 4 million gallons of water.




KEEP UP THE GOOD WORK - MILPITAS IS CLOSE TO ACHIEVING ITS WATER CONSERVATION GOAL!

Thanks to water-saving actions taken by residents, the City is getting close to meeting its 15% water conservation target. In December 2021, the City reduced water use by 13% compared to 2020 usage. To keep that trend going, the City continues to offer rebates and free tools to assist homeowners, residents, and businesses to conserve water. Starting January 10th, the City is increasing the rebate amounts for residential landscape conversions, rainwater capture, and graywater laundry-to-landscape systems. Apply now and receive a rebate up to \$5,000 for converting your high-water use lawn into a drought-tolerant garden.

Remember, we are all in this together! Please take these easy actions to save water:

- Turn off your irrigation when nature grants rain! The City does not allow outdoor watering during and within two days after it rains.
- Make sure to follow the City's three-day outdoor watering schedule.
- Use a hose with a shutoff nozzle for washing cars and watering.
- Check your toilets, pipes, and irrigation systems for leaks.
- Help us identify water waste. Use the MyMilpitas App or call 408-586-2666 to report violations of the City's water-use restrictions.

Rohde & Schwarz, located at 490 N. McCarthy Blvd. To allow an earlier start of operation, a temporary occupancy permit was issued to allow tenant to move in and set up furnishings and to conduct employee training without business operations.

Chick-Fil-A, located at 755 E. Calaveras Blvd. See below photo for construction progress on the building exterior with 3 coats of waterproofing and insulation. Interior work is still in progress.



Watchpoint Logistics, located at 607 N. McCarthy Blvd. To allow an earlier start of operation, a temporary occupancy permit was issued to Watchpoint Logistics for the warehouse section of the building.

Parkside at Tarob Ct (Phase III) Townhomes, 551 Lundy Pl., an 89-townhome residential development by Toll Brothers, Inc. The below photo shows the construction progress of various townhomes at different stages ranging from underground plumbing to exterior wall scaffolding with interior work in progress in 7 out of 13 buildings. 26 townhomes have been reserved or sold.



Crocus Technology, located at 870 N. McCarthy Blvd. To allow an earlier start of operation, a temporary occupancy permit was issued to Crocus Technology, a computer consultant firm developing and manufacturing state-of-the-art magnetic sensors.

City of Milpitas Fire Station 2, located at 1263 Yosemite Dr. See the below photo showing progress on the exterior construction of the new single-story fire station building which is receiving waterproofing. Interior of the building is in various stages with walls remaining open in most locations. The roof is nearly complete.



District Lot 4 (Gideon), 1400 McCandless Dr., an 8-story mixed-use project with commercial retail space and 213-unit apartment, wrapped around an 8-story parking garage by Lyon Communities. See construction progress in the below photo taken from the future Market Street near McCandless Drive with the completed Centre Pointe, DR Horton Townhomes in the background. The residential units are in the finish stage.

Element Hotel, 521 Alder Dr., a 5-story, 194-room hotel by LD Milpitas Lodging. To allow an earlier start of operation, a temporary certificate of occupancy for full operation of the new hotel was issued, effective January 31, 2022.



Chick-Fil-A, located at 755 E. Calaveras Blvd. See the below photo for the progress on the grading work to prepare for site improvements. Installation of doors and windows, as well as completing exterior insulation and lath, are also in progress.
