## NOTICE OF GENERAL MUNICIPAL ELECTION

### NOVEMBER 8, 2022 AND MEASURE TO BE VOTED ON

**NOTICE IS HEREBY GIVEN** that a General Municipal Election, consolidated with the Statewide General Election, will be held in the City of Milpitas on Tuesday, the 8<sup>th</sup> day of November 2022, for the following offices:

One Mayor of the City of Milpitas – full term, two years  
Two Members of City Council of the City of Milpitas – full term, four years

The filing period for these offices opens on **Monday, July 18, 2022** at 8:00 a.m. and closes at **5:00 p.m. on Friday, August 12, 2022**. If an incumbent does not file by 5:00 p.m. on August 12, any registered voter other than the incumbent shall have until 5:00 p.m. on Wednesday, August 17, 2022 to file a Nomination Paper for the elective office.

Nomination papers are available only from the City Clerk or Deputy City Clerk, at City Hall, 455 E. Calaveras Blvd., 3rd floor, Milpitas, from 8:00 a.m. to 5:00 p.m., Monday through Friday, during the nomination period. Candidates must be registered voters in the City of Milpitas at the time that the Nomination Paper is issued. Call the City Clerk at 408-586-3001 or the Deputy City Clerk at 408-586-3003 to schedule an appointment.

If no one or only one person is nominated for an elective office, appointment to the elective office may be made as prescribed by CA Elections Code §10229.

### MEASURE TO BE VOTED ON

**NOTICE IS HEREBY GIVEN** that the following measure is to be voted on at the General Municipal Election to be held in the City of Milpitas, on Tuesday, the 8<sup>th</sup> day of November 2022.

NOTICE IS HEREBY GIVEN that consolidated with the scheduled General Municipal Election to be held in the City of Milpitas on Tuesday, November 8, 2022, the Milpitas City Council on June 21, 2022 adopted a resolution calling for one ballot measure with an Ordinance to be voted upon by Milpitas voters. The ballot measure question is:

“Shall an ordinance be adopted amending the Milpitas Municipal Code to shorten councilmember terms limits by establishing for both councilmembers and mayor, effective with the November 8, 2022 General Municipal Election, a ten consecutive year limit on combined Mayoral and City Councilmember service, with a six year limit on Mayoral service, followed by a two-year “cooling off” period, during which a person may not serve as Mayor or a Councilmember?”	YES

The ballot measure proposes an amendment to the Milpitas Municipal Code shortening the time an elected official can serve as either Councilmember or Mayor to ten consecutive years with a six-year limit on mayoral service prior to a two-year “cooling off” period. The measure requires 50% + 1 voter approval to pass.

**Ballot arguments in favor or opposed** to the measure, limited to 300 words, may be submitted to the Milpitas City Clerk no later than Tuesday, August 16, 2022 at 5:00 PM. Rebuttals to the arguments in favor or opposed, limited to 250 words, may be submitted to the City Clerk no later than Tuesday, August 23, 2022 at 5:00 PM. In addition, the City Attorney shall prepare an impartial analysis for the ballot measure of no more than 500 words to be submitted to the City Clerk by Tuesday, August 23, 2022 by 5:00 PM. All items referenced in this paragraph **must be submitted in person to the Milpitas City Clerk** at City Hall, 455 E. Calaveras Blvd., Milpitas, from 8:00 a.m. to 5:00 p.m., Monday through Friday. Submitters are asked to make an appointment with the City Clerk or Deputy City Clerk in advance to turn in arguments or rebuttal documents. Arguments or rebuttals may not be submitted via e-mail, US mail, overnight delivery or scanned documents.

Polls will be open on Election Day, Tuesday, November 8, 2022 from 7:00 a.m. to 8:00 p.m. To get up-to-date Election Day and voting information go to [www.sccvote.org](http://www.sccvote.org) or call 408-299-8683.
