WORK TO BE PERFORMED UNDER THIS PERMIT IS LIMITED TO IS LIMITED TO INTERIOR TENANT IMPROVEMENTS AND NON-STRUCTURAL WORK, UNLESS NOTED OTHERWISE ON THE TEMPORARY PLAN SET AND/OR ON THIS APPLICATION. WORK SHALL NOT BE DONE THAT EXCEEDS THE LIMITATIONS AS STATED ABOVE. WORK SHALL NOT BE DONE ON THE EXTERIOR (INCLUDING THE INSTALLATION OF ROOF MOUNTED AC UNITS).
6. TEMPORARY PERMITS WILL NOT BE COMPLETED OR FINAL INSPECTIONS CONDUCTED UNTIL PRIMARY PERMIT IS ISSUED.
7. WORK TO BE PERFORMED UNDER THIS PERMIT DOES NOT INCLUDE ANY HAZARDOUS MATERIALS WORK.
8. OWNER AND CONTRACTOR WILL HOLD THE CITY HARMLESS FROM ANY AND ALL CLAIMS AS RELATED TO THIS PROJECT.
9. A BUILDING PERMIT WILL BE ISSUED ONLY AFTER THE PLAN REVIEW IS COMPLETED AND APPROVED AND ALL OTHER CITY, COUNTY, AND STATE APPROVALS HAVE BEEN RECEIVED AND ALL REQUIRED FEES PAID.

OWNER-BUILDER DECLARATION
