PAY TRANSPARENCY CERTIFICATION:

- A. Project Construction Employees received written notice of the employers' pay practices as required by California Labor Code section 2810.5 and wage statements under Labor Code section 226(a); or

"Unpaid wage theft judgment" means a judgment, decision or order, for which all appeals have been exhausted or the time to appeal has expired, that was issued by a court of law or an investigatory government agency authorized to enforce applicable federal, state and local wage and hour laws, including but not limited to, the Federal Fair Labor Standards Act, the California Labor Code, and the City of Milpitas Minimum Wage Ordinance, and which has not been fully paid or satisfied.
