The City Clerk's Office is currently accepting applications for the following Commissions:

Library and Education Advisory Commission: The Commission makes recommendations to the City Council on matters pertaining to the operation of library services and facilities in Milpitas. Meetings are held the third Monday of every January, March, May, September, and November, at 7:00 PM in the Milpitas Library Conference Room, or a designated location.

Parks, Recreation, and Cultural Resources Commission: The Commission advises the City Council on matters related to the operation and maintenance of recreation, leisure services, and historic preservation activities, and on the acquisition, planning, and development of new and existing parks and facilities. Meetings are held the first Monday of every month except July, at 7:00 p.m. in the Committee Conference.

Public Safety and Emergency Preparedness Commission: The Commission advises the City Council regarding emergency preparedness, disaster planning, public safety, crime, and quality of life with seven voting Commissioners and two alternate members appointed to three-year terms. All members and alternates shall be Milpitas residents, OR own a business or be currently employed at a business located within the City limits of Milpitas. Meetings are held the third Thursday of every January, March, May September and November, at 7:00 PM in the Training Room in Fire Station #1, or a designated location.
