## Business License Fee Schedule

- Effective August 1, 2020, a 3.8% Fire Department Permit Automation Fee will apply to **all** Fire permits for businesses located in the City of Milpitas per City Council Resolution No. 7940 adopted on December 1, 2009.
- Effective August 1, 2019, a \$57 Plan check fee will apply to **all new businesses** (except State Licensed Contractors and No Fixed Place of Business).
- Effective January 1, 2018, a \$4 State Mandated Fee for AB 1379 will apply to all local business license, similar instrument, permit, or renewal.
- **Please note, a \$50 new application fee for all new businesses or a \$25 renewal processing fee will apply.**

<b>No Fixed Place of Business</b> Businesses without a fixed place of business in the City of Milpitas providing retail or wholesale sales or services	<b>\$50.00</b> base rate for first vehicle <b>\$10.00</b> per vehicle for vehicles 2-7 in the City at any one time
<b>Palmist, Astrologers, Fortune Tellers</b>	<b>\$600.00</b> per person
<b>Real Estate</b> Real estate businesses without a fixed place of business within the City of Milpitas shall pay the same license fees, except that employees counted shall be those working within the City of Milpitas	<b>\$35.00</b> Base License Fee Employee Fee Calculation (in excess of one owner/manager): <b>\$5.00</b> per person for employees 1- 10 <b>\$1.00</b> per person for each additional employee thereafter
<b>Transient Vendors and/ or Solicitors</b>	<b>\$100.00</b> per person
<b>All Businesses Not Otherwise Classified</b>	<b>\$35.00</b> Annual Fee
